Removal of Bpay minimum amount required for additional investments

To provide more flexibility in managing your IOOF WealthBuilder investment bond, we have removed the \$500 minimum amount when making an additional investment via BPAY^{®1}.

BPAY is a secure and convenient way to make one-off investments² to your IOOF WealthBuilder account by calling your financial institution or visiting their website.

Guide to making BPAY payments

To make payments via BPAY, you will need:

- your Customer Reference Number (CRN)
- the applicable Biller Codes.

If you would like to use BPAY, your CRN is displayed on your Welcome Letter and Certificate of Membership provided to you when your account was first established. Otherwise, contact your financial adviser or our Investor Services team on 1800 002 217 to obtain your CRN.

BPAY is only available to investors with an Australian financial institution account. Please contact your financial institution to arrange BPAY.

Payments via BPAY generally cannot be reversed.

How to use **Bpay**

Step 1

Through your nominated financial institution's telephone or internet banking service, select the BPAY option.

Step 2

Enter the applicable Biller Code:
