#### **December 2024 Property Valuations**

Four of the Fund's directly held properties were independently valued during December 2024.

The property valuations resulted in an aggregate net decrease of \$0.25 million or (0.4%) from the properties' prior valuation.

In addition, the result reflects an aggregate net decrease of \$1.76million or (2.4%) from the properties' book value (BV) immediately prior to the current independent valuation.
