## Australian Unity Diversified Property Fund – ARSN 106 724 038

### Property revaluations

Two properties in the Fund's portfolio were independently valued during June 2019. Overall, valuations increased by \$6,098,596 or 8.66% from the properties' book value immediately prior to valuation, as follows:

**200 Victoria Street, Carlton, VIC** – The independent value of 200 Victoria Street, Carlton, VIC, increased in value by \$5,656,680 or 10.60% from the property's book value immediately prior to valuation. The increase in value is as a result of the capitalisation rate compression from 6.00% to 5.75% due to the buoyant transactional market and growth in net market income from low vacancy and improved leasing.

**19 Corporate Avenue, Rowville, VIC** – The independent value of 19 Corporate Ave, Rowville VIC saw the property increase in value by \$441,917 or 2.59% from the property's book value immediately prior to valuation. The increase in value is as a result of the capitalisation rate compression from 7.00% to 6.75% due to the buoyant transactional market.

At 28 June 2019 the Fund's gearing ratio was 39.28% and the gross assets stood at \$375.1 million with total borrowings of \$147.3 million.
