## August 2020 property valuations and settlement of acquisition

The property valuations resulted in a net increase of \$12 million or 14.1% from the properties' book value immediately prior to valuation.

**15 Butterfield Street, Herston, QLD** – The property's value increased by \$12.44million or 15.3% from the book value prior to valuation. This increase is the result of the re-signing of a five-year lease renewal with the anchor tenant, and the tightening of the property's capitalisation rate.

**Lot 507 corner Eccles and Florey Boulevards, Birtinya, QLD**– The property's value decreased by \$405,342 or -10.1% from the book value prior to valuation. The decline against book value represents the write-off of acquisition costs.

## Settlement of the acquisition of 33 & 40 Orth St, 26 Somerset St and 1, 3 & 5 Hargrave St, Kingswood, NSW

We are pleased to advise that on 19 August 2020, the Trust settled the acquisition of 33 and 40 Orth Street, 26 Somerset Street and 1, 3 and 5 Hargrave Streets, Kingswood, New South Wales for \$9.225m (plus acquisition costs). Located opposite the Nepean Public Hospital the properties are to be developed for healthcare-related usage.

### Trust borrowing details

As of 1 September 2020, the Trust's gearing ratio was 27.9% and the gross assets stood at \$2.26 billion with total borrowings of \$632.1 million.
