### June 2020 Property Valuations

As part of our active management approach and in response to market uncertainty resulting from the COVID-19 pandemic, we have independently valued all the Fund's directly held properties as at 30 June 2020 (except 40 Allara Street, Canberra which was held for sale and settled on 16 July 2020).

As ever, our focus is to act in the best interest of investors. We will continue to monitor the impacts of the COVID-19 pandemic and may seek to undertake independent valuations with greater regularity than the usual annual cycle as deemed appropriate.

The property valuations resulted in a total net increase of 0.06% or \$54,486 from the properties' book value immediately prior to the valuation.
