## Proposal to quote on Chi-X

On behalf of the Board of Directors of Australian Unity Funds Management Limited, as responsible entity of the Talaria Global Equity Fund (Fund), we are pleased to announce our intention to quote the Wholesale units of the Fund on Chi-X. If implemented, this would allow investors holding these quoted units to buy or sell units in the same way that they may be able to buy or sell shares in listed securities, as well as acquire and redeem units through the existing process (Proposal). The implementation of the Proposal requires the Fund's investors to pass a special resolution to make certain amendments to the constitution of the Fund.
